### REFUND/ATTENDANCE POLICY - NO EXCEPTIONS

#### CLASSROOM

- **Cancellations** - The school must receive written notification of a student's cancellation a minimum of five (5) days prior to the start of the course, for the student to receive a refund. All written notifications must be emailed to [info@rres-online.com](mailto:info@rres-online.com). For cancellations five (5) or more days prior to the start of the course, the refund is subject to a 10 percent cancellation fee. For cancellations received less than five (5) days prior to the start of the course, the refund is subject to a 25 percent cancellation fee.
- **Transfers** - Students must notify the school prior to the start of their registered course to be eligible for a transfer. Registration fees can be transferred to another course date, pending course availability, within 60 days of the initial course date. All transfer requests are subject to a \$40 transfer fee. If a transfer form is not completed within 60 days of the initial course date, the option to transfer will expire.
- **No Shows** - In the event of a no show, the student forfeits their registration fee.

#### ONLINE & SELF-STUDY

- **Cancellations** - The school must receive written notification of a student's cancellation within seven (7) days of the purchase date for a student's registration to be eligible for a refund.
